

- Snow route parking. Remember during heavy snow events, do not park along the marked snow routes and be careful about parking along the streets in general as the plows need to be able to get the snow off the streets which may result in your vehicle getting snowed in or towed in.
- With talk of snow, do you or someone you know plow snow in the area?? Maybe you need your driveway and/or sidewalks cleared after snowfalls (which the Farmer's Almanac is predicting to be a thing this winter!).
- Online payments. Did you know you can pay your water bill online? For a small fee to the card company, you can pay your water bill from the comfort of your own home. With the cold weather coming, who wouldn't want to stay inside and with just a couple of clicks of the mouse...done! Go to the village website: www.deercreekillinois.org and click on the "Pay Your Water Bill Here" tab. It's just that simple.
- With fall, comes fall clean-up. We do have a burn area north of town that you can take your yard waste (leaves, limbs, yard waste ONLY). You can burn your own leaves but do NOT burn on the street, including the edges of the street. It is illegal to burn anything other than yard waste. Finally, be mindful of your neighbors. It's just not nice to burn when the neighbors windows are open and the wind is blowing in their direction.



#### Did you know that there are property tax exemptions that you might qualify for? Here are just a few:

#### **General Homestead Exemption (GHE)**

- This annual exemption is available for residential property that is occupied by its owner.
  - The amount of exemption is the increase in the current year's equalized assessed value. Up to a maximum of \$6,000 in all counties.

#### Senior Citizens Homestead Exemption

- This annual exemption is available for property that is occupied as a residence by a person 65 years of age or older.
- The maximum amount of the reduction in equalized assessed value is \$5,000 in all counties.

# Low-income Senior Citizens Assessment Freeze Homestead Exemption (SCAFHE)

• This exemption "freezes" the senior citizen's property's equalized assessed value the year that the senior citizen qualifies for the exemption. Total household income must be less than \$65,000.

#### Homestead Exemption for Persons with Disabilities

• This exemption is an annual \$2,000 reduction in the EAV of the primary residence that is owned and occupied by a person with a disability who is liable for the payment of property taxes.

#### Homestead Exemption for Veteran's with Disabilities

A qualified veteran with a service-connected disability of at least 30% but less than 50% will receive a \$2,500 reduction in EAV; if the veteran has a service-connected disability of 50% but less than 70%, the annual exemption is \$5,000; and if the veteran has a service-connected disability of 70% or more, the residential property is exempt from taxation.
