- A. **Public Works Department** Remodel of old village hall update: PWA Rogers reported that the water shut off valve at the old village hall was not working. There is no shut off at the street for this building. They were able to get the water shut down to a trickle to do the necessary work, but the board may want to consider putting a curb stop at the street.

The base rates for the first 1000 gallons will remain the same.
