The village is waiting on updated construction costs for the water and sewer extensions and for the signed contract to be returned for approval. The attorney had updated the agreement to as follows: "the VILLAGE shall reimburse CIMINO, or at the election of CIMINO, pay to Schlueter Plumbing, the sum of \_\_\_\_\_\_ upon receiving proof that Schlueter Plumbing submitted its certified transcript of payroll to the Illinois Department of Labor through its electronic portal." If payment for expenses incurred needs paid prior to completion, the board is fine with that. Final payment will not be made until the above conditions are met.
