A. **Public Works Department** – It was reported that pump 2 at the wet wells had to be pulled again and cleaned. The bigger pump still needs to be repaired.

The village attorney was updated on the accident involving a fire hydrant and an uninsured motorist. The attorney's recommendation is to attach all costs to repair the hydrant to the violation issued and have this cost collected by the court.

B. Planning/Zoning Board of Appeals –
