At this time, Village President Hackney reported that the zoning board has recommended approval of the special use permit requested by Hawk Energy Solutions for a 22-acre solar farm. Attorney McGrath recommended proceeding with the approval only if contingent upon the following issues being addressed specifically in writing:

- Bond increases over time to assure enough funds available for decommissioning
- Greater setback and additional special conditions
- Emergency response plan in place
- Specific fencing requirements
- Locked entrances
- Specific vegetation requirements
- A decommissioning plan
- Highway authority plan

This is the time to put these conditions in writing.

Trustee Lee Berardi moved, and Trustee Kraemer seconded the motion to authorize the village attorney to prepare an ordinance laying out the necessary special conditions for a solar farm to be located within the village limits.
