MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF DEER CREEK HELD AT DEER CREEK COMMUNITY CENTER.

Village President Jim Hackney called the meeting to order at 7:00 p.m.

I.) ROLL CALL

Trustee Rossman moved, and Trustee Kraemer seconded the motion to approve the appointment of Nick McGahan as village trustee to fill the unexpired term of Judy Cremeens as recommended by the village president.

V.) OLD BUSINESS – Attorney Schricker reported that a letter has been sent to Dan Schlueter and Donna Cimino regarding the building structure at W First Avenue. The letter gave a 15-day notice to either enclose the structure or tear it down. A new building permit will need to be granted. Village President Hackney would like to propose an amendment to the village code that increases the cost of building permits that need to be reissued by 10 times the amount of the original permit. Permits are good for 12 months and there should be no problem with any construction taking longer than that to complete.

Trustee Lee Berardi moved, and Trustee McGahan seconded the motion to direct the village president to sign the Compliance Commitment Agreement with the IEPA pertaining to the violations associated with the wastewater treatment facility.

The Annual Financial Report (AFR) is due to be filed with the comptroller by October 27.

Trustee McGahan moved, and Trustee Kraemer seconded the motion to approve the fiscal year 2023 audit as presented.

The board discussed the replacement of sidewalks. It was clarified that the \$24,000 quote from Miller & Sons did not include the cost of the concrete; just the tear out, forming, and concrete pour and finish.

Trustee McGahan moved, and Trustee Hackney seconded the motion to approve the replacement of sidewalks by Miller & Sons at a cost of \$24,000 plus the cost of concrete.
